LONDON FREELANCE BRANCH MEETINGS

Power to the workies, syndicate abroad...

THE LONDON Freelance Branch meeting on Monday 13 June will celebrate the recent victory of Keri Hudson, who with the support of the NUJ won £1024 – the National Minimum Wage for five weeks of unpaid labour as an intern last year: see page 1. We'll have an update on the Cashback for Interns campaign (an LFB initiative), with more NUJ-supported cases bought by interns expected at small claims courts and industrial tribunals shortly.

Our speakers will be Keri Hudson herself; Martin Spence, assistant General Secretary of union BECTU, which first brought cases for backpay for media interns, LFB's very own Cashback for Interns campaign instigator Fiona O'Cleirigh and incoming NUJ General Secretary Michelle Stanistreet. We may also hear from NUJ Legal Officer Roy Mincoff, who has been active in Cashback for Interns cases. We're back at the usual Friends' House venue for this and other meetings this year.

Syndicating your work abroad is the theme of the meeting on Monday 11 July. We will have speakers from International Features Agency (IFA) in Amsterdam. Freelance Organiser John Toner will describe some of the issues members face when selling work abroad.

There is no meeting in August.

Policing is the provisional topic of the meeting on Monday 12 September. Partly as a result of years of hard work by the NUJ, and especially its Freelance Office, working journalists on the streets have reported significant improvement in police behaviour towards them. We'll look at the latest developments in police-press relations, and some forthcoming developments in this area. Speakers will include high-ranking Metropolitan Police people. Watch this space for updates and speaker details.

This issue went to press on 31 May. Deadline for the printed August/September issue is 29 July.

LFB meetings are from 7pm to 9pm at Friends's House, Euston Road, which is accessible to people who use wheelchairs. Her election has created a vacancy for NUJ Deputy General Secretary (DGS). If you have been in the NUJ for five years, have at least three years' experience as an official or lay officer of the Union, and are fully paid up with no subscriptions arrears, you are eligible to stand for election as DGS.

There's already a DGS election hustings planned for Tuesday 19 July in Birmingham, and the web site will list other hustings events.
