Chasing © infringers, Small Claims courts

WE ARE assured that – barring any hitches with the *Journalist/Freelance* mail-out – the newsletter you are reading is about to have reached you in time for the LFB meeting on **Monday 12 May**.

With fingers crossed in anticipation of the print Freelance's timely arrival, we inform you that the May LFB meeting will hear "How I paid my mortgage by chasing internet sites who'd stolen my work – a photographer's tale".

Our speaker will be John Walmsley, a photographer who's done exactly that — chasing unauthorised uses of his work online and extracting payment for it. John's photos are in the permanent collections of the National Portrait Gallery and the Bibliothèque Nationale, Paris, and you can see some of his work on www.educationphotos.co.uk.

Is a publisher demanding you give them legal indemnity? Or infringing your copyright? Are you being sued? The Union can help, and there will be advice at Branch meeting on **Monday 9 June**.

NUJ Freelance Organiser John Toner will lead the discussion, which we hope will include advice on how to deal with the problem of freelances facing demands to indemnify employers against defamation and legal risks. Also covered will be the recent successes in the new "intellectual property" Small Claims court track, thanks to the support of the NUJ Freelance Office. Defamation, and the changes brought in by the Defamation Act, is also likely to be covered in a forth-coming LFB meeting, possibly in June. Speakers are likely to include a lawyer and a freelance member who's successfully defended a libel action. Visit the web page below for more.

A TRADES Council is a meetingplace for local trades unionists sharing news of upcoming strikes and to chase the local council on commitments they have made.

Lewisham Trades Council, for example, was active in the campaign to save Lewisham Hospital's A & E Department. Trades Councils have seats at the Trades Union Congress (TUC) conference and are useful for submitting motions to the TUC.

Journalists are, it seems, not that popular; Trades Councils remind others in the trade union movement that we are trade unionists too.
